The Client shall not sell said negatives and/or prints or authorize any reproductions thereof by parties other than Dawson's Photos. If Client is obtaining a print for newspaper or other publications, Dawson's Photos authorizes Client to reproduce the print in this manner. In such event, Client shall request that a credit for Dawson's Photos run adjacent to the photograph. The Client must obtain written permission from and compensate Dawson's Photos prior to an event where the Client, the Client's friends or relatives publish or sell the photographs for profit.*
